

The shock that my legs would not fire to allow me to stand was unnerving. I asked the therapist what can I do besides have them lift me in a hover machine like a sack of potatoes from the bed to the wheelchair, take me to the therapy room, and then return me back to my room in the wheelchair - the hover machine - and lift me back into my bed and help remove the back brace I had to wear. The therapist gave me a set of exercise to do while I laid in bed watching Taco Bell commercials and re-runs of canceled programs. The neurosurgeon told me I could do anything I set my mind to. Will I walk again? Yes, if I work at it. Will I be able to go rock hounding again? Yes, within reason. (I no longer have an L3 vertebra, but instead I have 9 titanium screws holding me together). Will I be able to wear a 20 pound backpack holding my rock hammer, gad bar, sledge hammer and chisels with room for found rocks? No, but I could wear a fanny pack around my waste for reasonable sized rocks found while carrying a rock hammer in my hand. Well, I did not resign the chairmanship. It took me 4 weeks to learn to walk again and another 2 weeks more to have the pic line removed from my arm where I had my antibiotic drip ball three times a day.

I had several club members volunteer well in advance, such as Ron Dingley, Larry Friend, Carl Woodlawn, Janelle Wintersteen, Blaine Dahlstrom, Jay Erb, Tammy Payne, Loren Francis, Don Nafus and Ilse Schreiner. As the day progressed and volunteers moved from my table to other table venues where they had signed up to help, we developed a few gaps in the time slots at the silent auction table. To my delight, other club members simply came by my table and entered the silent auction area to help where help was needed. I would like to call out their names in recognition of their help, as I truly appreciated their generosity in giving their time to help; Andy Housh, Randy Brown and Carl Woodlawn. If I have missed your name, please forgive me...

I would like to give a special thank you to Larry Friend and Ron Dingley, who spent nearly the whole day - both days - back with me at the silent auction table. I really don't know what I would have done without these two fellows!

FEDERATION DIRECTOR REPORT MARCH 3, 2020

NFMS Annual Meeting, Ogden, Utah, April 10, 2020 at 4 pm.

CEQ (Council on Environmental Quality) is proposing process simplification and timeline contractions for NEPA (National Environmental Policy Act) of 1969. NFMS President, Kenneth Zahn, encourages each club to write a response by the deadline, March 10, 2020.

Summary Statements: The Feds push to reduce scope and time of environmental reviews, especially highway and energy infrastructure projects. It is necessary to review BLM's and USFS's review process for local-area recreation-related projects in recent past. Keeping up with this is a full-time responsibility of all club members.

- 1. Limits scope of NEPA review (excludes non-federal projects with minimal federal funding or involvement as agency cannot control outcome of project).
- Eliminates cumulative impact analysis (due to geographic and temporal scope it's difficult and diverts focusing time and resources on significant effects with encyclopedic documents with irrelevant or inconsequential decisionmaking process).
- Requests comments on GHGs (Green House Gases). How NEPA analyses should address GHG emissions is unclear as to the impact of eliminating the analysis as it has a global cumulative effect.

4. Establishes 2-year time limit on EISs (Environmental Impact Statements) completion — current 4 years. Time equals date of notice of intent to date of recorded decision signed.

Items Emailed to IGC Members This Past Month

- Lowman Ranger District requests grant for vault toilet at Mountain View Campground from Recreational Vehicle Fund.
- 2. Midas Gold to write key environmental report on its proposed open-pit gold mind in Central Idaho.
- 3. Oregon Boating Law requires education card by Idaho boaters once they have entered the Powder River Arm of Brownlee Resevoir, but not on border waters.
- 4. Two-Bit Road Decommissioning Project related to Six-Bit Creek and Curtis Creek subwatersheds.

Idaho Public Lands Access Guide does not include Recreational Rockhounds. I requested they be included. SME Tech Sessions on March 11, 2020, with regards to Geological Mapping of Mining in Idaho.

Nez Perce/Clearwater Forest Service Revision Plan. I attended the Open House today, March 3, 2020.

- 1. Talked with forest service supervisor to consider older rockhounds' limited ability to reach areas without vehicle access.
- 2. Plan and comment before April 20 deadline.




BRAD'S BENCH TIPS

IDENTIFYING UNMARKED SOLDERS

There are plenty of ways to mark your sheet or wire solders, but suppose you forgot to mark them and have a couple that you can't identify. The answer is to compare the melting temperature of the unknowns with that of a known solder. What I do is take a thick scrap of copper or nickel and arrange several solders on it. Ideally, I would have a sample of easy, medium and hard known solders surrounding the unknown solder. Then I heat the plate from the bottom and watch the order in which the solders melt.



INEXPENSIVE ELECTRIC WAX PEN

You can make your own wax pen from a small soldering iron plugged into a light dimmer switch for heat control. Both components are easily found at a big hardware store or at Harbor Freight. As an example of the components, see items #43060 and #47887.

File the tip of the soldering iron into the shape you prefer or even better get a soldering iron with replaceable tips. Then you can make several tip shapes for different tasks. Set the dimmer control just hot enough to melt the wax without producing any smoke.

A tip design that I find ideal for some work is a length of small gauge wire that lets me reach in around the model to melt some wax. The wire is 18ga and about 15mm long. I use Sterling wire to conduct heat easily to the tip, and I silver solder it into a hole on the end of a copper or brass rod that fits into the soldering iron.


